## **Add Group Home Daycare to Zoning Ordinance:**

Carol Russell, a Township resident, wants to open a licensed Group Home Daycare in her home to care for 7-12 children. She lives in an R-1 district. When our ordinance was written, the term Group Home Daycare didn't exist, so we don't have anything in our ordinance to allow it. We will research proper wording and definitions and will address it at our next meeting.

## **Public Hearing:**

Motion by Ross Schneider, seconded by Hope Partlow to make corrections to our zoning ordinance. When the zoning ordinance went into effect in 2000 and digital mapping wasn't as precise as it is now, seven parcels of land adjacent to the industrial park off Lyons Road were erroneously zoned. Four parcels, two on each side of Industrial Drive will be rezoned R1 from Industrial; 1 parcel across Lyons Road from Industrial Drive will be rezoned AG from Industrial; two parcels between the industrial park and THK will be rezoned Industrial from AG. All were in favor. The PC is recommending approval of the change to the Township Board. The Board can adopt this change next week.
